Individual Artist Exhibitions at the Santa Cruz County Government Center 2011 Exhibit Year

Artists and craftspeople residing in Santa Cruz County are invited to apply for space in the Santa Cruz County Government Center (701 Ocean Street, Santa Cruz) in which to show their art during the 2011 Exhibit Year.

Art works will be displayed on the walls of the 1st and the 5th floors of the building or 3D work within 3 glass display cases that are 92" long x 19" deep x 21" high.

Eligibility:	<ul style="list-style-type: none"> ▪ Artist must be a resident of Santa Cruz County ▪ Artist must <i>not</i> have participated in exhibitions at the County Building during the 2010 Exhibit Year.
Application:	<p>To apply, artists must submit an application package by November 9, 2010. The package must contain:</p> <ul style="list-style-type: none"> ▪ \$25 non-refundable application fee. ▪ Five professional digital images (see Application on page 2 for details.) ▪ A recent résumé. ▪ Brief statement about work to be exhibited (see Application on page 2 for details). ▪ Self-addressed, stamped envelope for return of materials (see Application on page 2 for details.)
Selection:	<p>Application packages will be screened at the Cultural Council of Santa Cruz County by a panel consisting of:</p> <ul style="list-style-type: none"> ▪ Two professional artists ▪ One Cultural Council Board Member ▪ One Santa Cruz County Arts Commissioner ▪ A representative from the County Parks & Recreation Department ▪ Two County employees

<input type="checkbox"/> Return Envelope	6x9 or larger Envelope, addressed to yourself with correct postage for returning your CD.
<input type="checkbox"/> Résumé	Must be current.
<input type="checkbox"/> Artist Statement	2 – 3 sentences describing your work suitable for screening, publicity & brochure. Must be typed, printed, or otherwise legible.
<input type="checkbox"/> Five Digital Photos on CD (NOT DVD)	File type: .jpg (MAC users make sure that you use “jpg” and not “jpeg”.)
	File size: cmyk - 300 dpi, 5 X 5” maximum.
	File name: Your initials followed by the image number: e.g., doe-1.jpg, doe-2.jpg, etc.
	Index: Printed list of each work with: NAME, MEDIUM, DIMENSIONS, YEAR CREATED and corresponding FILE NAME

ALL OF THE WORK SUBMITTED MUST BE REPRESENTATIVE OF THE STYLE AND CONTENT THAT YOU PLAN TO EXHIBIT AND MUST NOT BE OLDER THAN TWO YEARS. Remember that the County Government Center is not a gallery; plan to display work appropriate to a public office building. Religious or political subjects, nudity, and violence are not acceptable.

Notification of Acceptance:

Artists will be notified of the panel’s decision by December 30, 2010 and scheduling of the exhibition will be arranged. Location of the exhibition within the County Government Center is at the discretion of the Cultural Council.

Additional Exhibition Space:

Artists’ submissions may also be viewed for exhibition purposes by representatives from public facilities other than the County Government Center, including County Health Services, Simpkins Family Swim Center etc. These facilities may choose to contact the artists with an offer of exhibition space at these locations. If you prefer not to be considered for exhibitions at these spaces, please check here: Your work may also be selected for display at the Cultural Council office (not a public venue). If you prefer **not** to have your work displayed at the CC office, please check here:
